##### **Child Nutrition Request for Proposals (RFP)**

Important dates from the Texas Department of Agriculture (TDA) for new or renewal of Food Service Management Company (FSMC) contracts:

- December 15, 2023: All applications to conduct an RFP must be submitted.
- April 1, 2024: Contract selections must be submitted to TDA for approval.
- May 1, 2024: TDA to approve all FSMC new contract and renewal submissions.
- June 21, 2024: New contract and renewals must be signed/executed and submitted to TDA.

##### **North Crowley High School Cell Tower Lease**

Cingular Wireless is proposing a cell tower lease for property located at North Crowley High School. This lease could generate revenue for the District for the next 50 years.
