Future Action Item(s)

Consider and Take Action on an Order Calling a Board of Trustees Election in the District on May 3, 2025

A general election will be held on Saturday, May 3, 2025, for the purpose of electing three Crowley ISD School Board Trustees (Places 5, 6 and 7) to serve on the Crowley ISD School

Board. HB 1, passed in 2006, requires district trustee elections to be held on the same date as 1) the election for members of the governing body of a municipality located in the district or 2) the general election for the state and county officers. The voters of a joint election will be served by common polling places consistent with Election Code 271.003(b). This is a future action item.

Naming of Elementary School #17

Elementary School #17 is scheduled to open in Fall 2025 in The Bridges neighborhood. Per Board Policy CW (LOCAL), responsibility for the final decision in naming or renaming schools and other facilities within the district rests with the Board.

The Administration provided information regarding the policy which also included information on standards and guidelines, the recommendation process and more. This is a future action item.

RFP-047-2024-2025 CISD Multi-Purpose Stadium Naming Rights

Crowley ISD continues to seek innovative revenue generating opportunities to support District programs. District's across Texas have realized significant revenue streams through solicitations for naming rights agreements for their athletic stadiums. These funds have been used for a wide variety of purposes in support of District programs and initiatives. As such, Crowley ISD issued an RFP to obtain proposals from prospective bidders to purchase naming rights for the Crowley ISD Multi-Purpose Stadium. There were two (2) respondents to this RFP.

Crowley ISD will begin the negotiation process with the respondents and ultimately bring this item back to the Board for approval at a later date.
