Facility Naming Procedures

Introduction of Student Voter Empowerment Club and March to the Polls Sponsors

STEM Plus for All Activities

STEM Plus is helping fulfill Crowley's Vision 2025 to provide all students with choices and access to early STEM opportunities and secondary CTE pathways. This means students are challenged with STEM learning in the classroom and extracurricular activities to apply their learning to real-world applications. The Crowley ISD STEM Plus program focuses on building capacity in our learner profiles and their 21st century skills. STEM Plus focuses on student learning through applications of cultural relevance, collaboration, engineering design process, and communication skills.

Students are introduced to STEM and STEM careers through exploration and creative hands-on activities in Pre-K through 2nd grade. Students in 3rd through 5th grades engage in student-centered learning to identify projects for which they are passionate. At the four middle schools and two ninth grade campuses, students are able to select electives that pique their interests and lead them into a career pathway in high school. Students will also have access to after school programs or clubs through STEM Plus.

Future Action Item(s)

Consider and Take Action on an Order Calling a Board of Trustees Election in the District on May 4, 2024

A general election will be held on Saturday, May 4, 2024 for the purpose of electing two Crowley ISD School Board Trustees (Places 3 and 4) to serve on the Crowley ISD School Board. This is a future action item that will be brought back for consideration and possible action during the January 25, 2024 Regular Board Meeting.

Purchase of Kitchen Equipment for School Cafeterias

The following purchases are planned to improve food service at campuses across the District:
15 reach-in refrigerators
2 pass-through refrigerators

1 roll-in refrigerators
5 reach-in freezers
20 reach-in heated cabinets
3 pass-through heated cabinets
1 roll-in heated cabinet

These purchases will be paid with the Child Nutrition Fund as part of the District's spend down plan. Approximately \$70,000 to \$75,000 total to be paid with the Child Nutrition Fund. This is a future action item that will be brought back for consideration and possible action during a future Board Meeting.

Development of 2024-2025 School Calendars

The District is in the planning stages of developing the 2024-2025 school calendar that maximizes instruction time for students and planning/development time for educators. Drafts of the calendar will be reviewed by the Executive Leadership Team, the District-Wide Educational Improvement Council (DWEIC) and principals before being brought to the School Board possible action at a future meeting. This is a future action item that will be brought back for consideration and possible action during a future Board Meeting.

Naming of Elementary School No. 16

Elementary School #16 is scheduled to open in Fall 2024 in the Karis neighborhood in the City of Crowley. No. 8584 Discussion of Districtwide Intruder Detection Audit Report Findings

The Texas School Safety Center recently conducted an Intruder Detection Audit at one or more of the District's campuses. The state gives school districts 45 days from official notification to enact corrective actions and we took immediate action as a response to the findings. While the District is not releasing any sensitive details to the public regarding the audit in open session, a corrective action plan was put into place due to the findings. This audit is conducted as part of Governor Abbott's school safety directives for all school systems to help school districts identify how campuses can improve safety for our children and staff, such as ensuring exterior doors are locked.

The audit provides Crowley ISD with an opportunity to create a safer learning environment and is just one of the many actions that the district is taking to ensure that our schools are safe. Following the statement made by the District, no further action was required or taken.
