# **Competitive Sealed Proposal (CSP)**

A competitive sealed proposal (CSP) is a process where potential contractors independently submit detailed proposals, including technical specifications, pricing and relevant experience, in response to the district's request.

The contract is then awarded to the proposer whose proposal offers the best value, considering factors beyond just the price.

We base evaluation criteria per Texas Education Code. 2269.

- The offeror's experience and reputation
- The quality of the offeror's goods or services
- The offeror's proposed personnel
- Any other relevant factor(s) specifically listed on the request for bids, proposals or qualifications


